

# TERMS OF SERVICE

## YouTube Shorts Academy (YTSA)

**Last Updated:** 23<sup>rd</sup> of January 2026

### 1. Agreement to These Terms

By purchasing, accessing, or using YouTube Shorts Academy (YTSA), you agree to these Terms of Service. If you do not agree, do not use the service. YTSA is operated by an Australia-based sole trader.

### 2. Digital Products and Services

All YTSA products and services are digital only.

This includes courses, videos, templates, community access, coaching, and feedback.

No physical goods are shipped.

### 3. Access and Account Responsibility

Upon purchase, you may receive access to:

- Course materials
- Private community
- Feedback systems

You are responsible for keeping your account secure. Account sharing is strictly prohibited.

### 4. No Guaranteed Results

YTSA provides education and guidance only.

Income, views, subscribers, monetization approval, and algorithm performance are not guaranteed.

Results depend on effort, consistency, execution, and external factors.

Any examples shown are illustrative only.

### 5. Conditional Refund Policy (90-Day Effort-Based Guarantee)

YTSA offers a **conditional refund guarantee** based on full implementation.

To qualify for a refund, you must meet **all** of the following requirements:

1. **Post consistently for 90 consecutive days** using the strategies taught inside YTSA, in accordance with a posting schedule approved by YTSA
2. **Operate in an agreed niche**, confirmed through YTSA guidance
3. **Actively seek feedback daily**, including submitting content for review and making documented improvements
4. **Implement feedback properly and in good faith**
5. **Fail to generate results equivalent to the amount paid for one month of YTSA within the 90-day period.**

For the purposes of this guarantee, “results” are defined as **estimated advertising revenue generated directly from YouTube Shorts views** on the channel used during the 90-day period.

Revenue equivalence will be calculated using a **standardised RPM of \$0.30 USD per 1,000 views**.

For clarity, all refund calculations are assessed in USD, regardless of the currency used at checkout.

This RPM (\$0.30 USD) is used solely for refund eligibility calculations and does not reflect actual or guaranteed earnings.

If the total views generated during the 90-day period, when calculated at this RPM, meet or exceed the cost of one month of YTSA, the user will not be eligible for a refund.

If these conditions are met, you may request a refund.

## **Proof Requirements**

You must provide verifiable proof, which may include and is not limited to:

- Channel links
- Upload history
- Analytics screenshots
- Feedback submissions
- Communication logs

Failure to provide proof will result in denial of the refund request.

## **Refund Requests**

Requests must be submitted in writing within **7 days after the 90-day period**

Refund decisions are based on evidence of genuine implementation

Approved refunds will be issued to the original payment method

Chargebacks or payment disputes may result in immediate access termination.

Nothing in this policy excludes rights you may have under Australian Consumer Law.

## **6. Acceptable Use**

You agree not to:

- Share or resell YTSA content
- Copy or redistribute materials
- Harass other members
- Spam or self-promote without permission
- Attempt to exploit systems or staff

Violations may result in removal without refund.

## **7. Intellectual Property**

All YTSA content is owned by YTSA.

You receive a limited, non-transferable license for personal use only.

Commercial redistribution is prohibited.

## **8. Termination**

We reserve the right to suspend or terminate access for violations of these Terms.

Termination does not remove your obligation to follow these Terms.

## **9. Limitation of Liability**

YTSA is not responsible for:

- Financial losses
- Platform bans
- Algorithm changes
- Business decisions made by users

## **10. Governing Law**

These Terms are governed by the laws of **Australia**.

You agree that any disputes will be subject to the exclusive jurisdiction of the courts of Australia.

We may update these Terms at any time.

Continued use means acceptance of updated Terms.
